FUSC Update-Federal Universal Service Charge

Effective July 1st, 2023 the Federal Universal Service Charge (FUSC) contribution factor will be increasing from 29.0% to 29.2%. The FUSC amount is calculated by multiplying the contribution factor times your interstate service charges. This factor may change quarterly, depending upon the needs of the Federal Universal Service Fund (USF). The USF is a government mandated program that is designed to help make phone service affordable and available to all Americans, including consumers with low income, those living in areas where the costs of providing telephone service is high, and to schools, libraries, and rural health care providers.

Access Recovery Charge Update

Due to FCC Rules (which became effective December 29, 2011) the Access Recovery Charge (ARC) enables Bernard Telephone Company to recover from end-user customers a limited portion of revenues lost due to FCC mandated reductions in interexchange carrier payments. The current Access Recovery Charge on your bill will decrease effective July 1, 2023. If your account is charged at the residential or single-line business rate, the ARC will decrease from \$3.00/month to \$2.50/month. Multi-line business ARC rates will remain at the current \$3.00/month rate.

putting up a fence or clothes line, planting trees or shrubbery, landscaping, building a home addition, deck, foundation, or replacing a driveway or sidewalk, etc.) you must submit a locate request at least 48 hours (not counting weekends and/or legal holidays) prior to excavation. Iowa One Call will notify the underground facilities in the area of planned excavation.
